for display during the **2015 Dublin Irish Festival**

Deadline for Entries: Monday, July 13, 2015

Art Drop off: Saturday, July 18, 2015, 9:00 -10:30 AM

The Show will be Judged and hung by Monday, July 20, 2015

Take Down and Pick Up: Saturday, August 15, 2015, 9:00 -10:30 AM

Rules for the 2015 Dublin Area Art League Irish Art Show:

Artists may enter up to two (2) pieces of 2-dimensional art, in any medium, portraying views of Dublin, Ohio; Ireland; or the Irish people. **Special Note to artists who participated in the 2015 DAAL Paint Out: you are eligible to enter your work if it meets the specifications below.

Entry Fee: \$15.00 for non-members; \$10.00 for members; fee covers up to two works.

Prizes: People's Choice Ribbon; First Place Ribbon \$100, Second Place Ribbon \$75, Third Place Ribbon \$50; Honorable Mention Ribbon. **Note: Ribbons will be attached after the public has voted for People's Choice, at the end of the day on Sunday, August 9.**

Judging: Sunday, July 19; Art will be on exhibit at DCRC July 20 through August 15.

Specifications: Each piece must be no larger than 24 inches x 24 inches framed, to allow for up to 20 pieces to be exhibited on the DAAL exhibit wall at DCRC. Submissions must be the artist's original work, properly wired for hanging ("saw tooth" hangers will not be accepted). Unframed canvas paintings must have the edges finished. Paintings must be dry to the touch. DAAL is not responsible for any damage.

Artist's Statement: Please prepare a short written statement (between 25 and 125 words) for each entry. The statement must explain how the art relates to Dublin, Ohio; Ireland, or the Irish people. If it was done at a plein air paint out, or while at a favorite place or event in Dublin, etc.—please tell us. This will be printed in the show brochure.

Art should be marked for purchase: It is the responsibility of the artist to make arrangements to meet with the buyer for the exchange. Hang tags must include artist's contact information. DAAL will not handle transactions. If a piece is sold during the dates of the Irish Festival to a non-local patron, it may be removed by the artist before the final exhibit date of August 15.

Release of Liability: Participating artists must sign the DCRC art show waiver of liability
